

# **TasTAFE Learner Engagement Survey**

## **About the Learner Engagement Survey**

Each year TasTAFE reviews the level of service it provides students. The Tasmanian research firm, EMRS, has been appointed to survey students about their experiences with TasTAFE's training in 2025 via a link to an online survey and by telephone contact to selected students.

Feedback helps TasTAFE improve the services it offers, and we would like to hear from you with any views that you may have – whether it is to comment on positive experiences or to highlight areas for improvement.

Whilst there is no obligation for you to participate in this survey, your involvement would be greatly appreciated as your responses could have a positive effect for future students.

On 2 February 2026, EMRS sent students a survey link from which to access the survey. The survey takes approximately 10 minutes to complete. If you do not wish to participate in the survey, there is an opportunity for you to opt-out/unsubscribe.

All the information you provide is treated in the strictest confidence and no individual student details, comments or responses are disclosed to TasTAFE. The information gathered is aggregated to obtain an overall picture of students' experiences at TasTAFE.

## **RANDOM PRIZE DRAW**

As an incentive to participate, once you have completed the survey, your name will be entered in a random draw to win a pre-paid VISA gift card worth up to the value of \$500. The Total Prize Pool is valued at \$1,500 and will consist of two fortnightly draws. The first draw will be for one prize of \$500. To be eligible for the First Prize Draw, entries must be received by midnight on Friday, 13 February 2026. The second draw will be for two prizes of \$250 and five prizes of \$100. To be eligible for the Second Prize Draw, entries must be received by midnight on Friday, 6 March 2026. Unsuccessful entries to the First Prize Draw will be automatically entered into the Second Prize Draw. ## **TERMS & CONDITIONS OF THE RANDOM PRIZE DRAW**

3. Employees (and their immediate families) of the Promoter and Sponsor associated with the Promotion are ineligible to enter the prize draw. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
